- 1. 1. Introduction

Indian National Centre for Ocean Information Services (ESSO_INCOIS), a unit of Ministry of Earth Sciences, Govt. of India is a premier scientific Institute of the country, functioning on 24x7 basis to provide Ocean data, information and advisory services to society, industry, Government and Scientific community through sustained ocean observation and constant improvement through systematic and focused researching information and Ocean modelling.

INCOIS had planned to establish a real-time GNSS and Strong Motion Accelerometer (SMA) network at 35 locations in Andaman & Nicobar (A & N) Islands to improve the timeliness and accuracies of earthquake detection and tsunami early warnings. Out of the 35 locations, construction of recording room of size approx. 3x3 m with compound wall of size approx. 10x10 m for the installation of GNSS and Strong Motion Accelerometers (SMAs) network is completed and being maintained at 32 locations. The observatories are equipped with a suite of sensors such as Strong Motion Accelerometer with digital recorders, solar power systems, battery chargers, GNSS receivers with antennas, met packages and relevant solar power system, charge controller, lightening and surge protection etc. These stations are also equipped with VSAT antennas for real-time data transmission. 2.1 The detailed scope of work includes:

- Repair/Replacement of civil works that includes cracks & filling and masonry works required for the
 recording room and compound wall, gate, solar panel pillars, GNSS and VSAT antenna pillars, and
 seismic pier, flooring tiles, repair of outdoor ramp for the sites as mentioned in the Table -1.
- Replacement of doors for the sites as mentioned in the Table-1. The door material should be Aluminium
 Composite Panel (ACP) with a suitable door frame / framework for the door and other materials are
 not accepted. The doors should be strong enough to withstand all kinds of weather.
- Repair of windows, ventilators, seismic pier closure for the sites as mentioned in the Table-1,
 Replacement of broken window glasses with min. 3mm thick solid transparent polycarbonate sheets
 and seismic vault/pier closure with double layered 18mm WPC/PVC Sheet or with suitable thickness

NB: - The paint consumption of the executed quantity should tally with the manufacturer's specification.
