Sub: Re-organization of activities at INCOIS

With immediate effect and until further orders, INCOIS activities are re-organized as set forth in this Office Order.

1. Activity Grouping:

In order to achieve operational and research efficiencies across the full spectrum of activities encompassing the institutional mandate and future aspirations, INCOIS activities and human resources are re-organised into three Groups and eight Divisions as follows:
